Supervisor Ziegelbauer moved to approve the payment to the Humane Society. Motion seconded by Supervisor Goehring. Carried. Julie also distributed for information the open claims list for the end of December.

Finance Director Sheree Reininger distributed and reviewed the carryover requests and the draft Resolution for Carryover of Unexpended 2009 Appropriations to 2010. **Supervisor Goehring moved to approve the carryovers and authorize the resolution to be introduced at the January 19th County Board Meeting. Motion seconded by Supervisor Ziegelbauer. Carried.**

Sheree also distributed and reviewed the jail statistics for December and answered questions regarding the vouchers from the last meeting.

Vouchers were reviewed. Supervisor Ziegelbauer moved to approve the expenses. Motion seconded by Supervisor Abler. Carried.
