#### **DISCUSSION/ACTION ENERGY SAVINGS STATUS**

Savings exceed expectations; approximately 6.7% (\$19,000) saved in natural gas and 8.8% (\$32,000) in electrical costs. Total savings goal was \$50,000.

#### DISCUSSION/ACTION AGRICULTURAL BUILDING

- Name Change to ADRC Building Moved by Epping/seconded by Van Dixhorn to change County ordinances accordingly to reflect ADRC Building; motion carried.
- Federal Lease Requirements Building surveyed in order to meet requirements of Federal government. Concerns include ADA handles for the sink; guards on pipes below restroom sinks; and, brail signage. Committee agreed to make necessary changes.

#### **DISCUSSION/ACTION PROJECT STATUS**

TeBeest reported two light poles will be replaced in spring around the University of Wisconsin Sheboygan Information Technology Center; there is a problem with the Emergency Notification fire alarm panel for the Courthouse; display ad out for Law Enforcement Center air condition units 6 & 7; vendor quoting to replace door hardware in Law Enforcement Center; the HVAC control upgrades experiencing problems with interface communicating with Rocky Knoll chiller; pre-construction meetings underway for the Morgue upgrade; site visits conducted relating to Detention Center Security System upgrade; and the Sheboygan County Economic Development Corporation moved in on the 2<sup>nd</sup> floor of the Administration Building. Concerns regarding lease to be addressed with Corporation Counsel.
