  Merging the Planning and Land and Water Conservation Department

Pat requested approval of the Sheboygan County Emerald Ash Borer (EAB) Community Resource Management Plan Guide. Supervisor Bosman made the motion to approve the EAB Community Resource Management Plan Guide and introduce it at the next Sheboygan County Board Meeting. Supervisor Ogea seconded the motion. Motion carried.

Pat reviewed the proposed 2011 Land and Water Conservation Department Budget with the committee. A motion to approve the 2011 Land and Water Conservation Department budget as presented was made by Supervisor Bosman and seconded by Mike Rammer. Motion carried.

Motion failed due to a lack of a second. .A motion to approve the proposed 2011 Register of Deeds budget as presented was made by Supervisor Bosman and seconded by Supervisor J. Van Dixhorn. Motion carried with Supervisor Ogea voting nay and Mike Rammer abstaining.

Aaron Brault reviewed the proposed 2011 Planning and Resources Department budget Supervisor Ogea made a motion to add \$10,000.00 to the Hazardous Waste Program which will result in a variance of \$33,375.00 for the Planning and Resources Department. Supervisor Bosman seconded the motion. Motion carried. Supervisor Ogea moved to add \$2,500.00 to the Maintenance Budget for the Marsh (Broughton) Park which will result in a final variance \$30,875.00. Supervisor Bosman seconded the motion. Motion carried.

Correspondence for the UW-Extension – Dave Such distributed a copy of Local Government Guide to committee members.

Dave distributed the UW-Extension Staff Narratives. Supervisor Bosman made a motion to approve the staff narratives and Supervisor Ogea seconded the motion. Motion carried.

Dave requested approval for the 133 Contract between the Board of Regents of the University of Wisconsin System and Sheboygan County for the UW-Extension Agents' salaries from July 1, 2010 to June 30, 2011. A motion to approve the 133 Contract was made by Mike Rammer and seconded by Supervisor Bosman. Motion carried.

Dave reviewed the proposed 2011 UW-Extension budget with the committee. A motion to approve the 2011 UW-Extension budget as presented was made by Supervisor Bosman and seconded by Mike Rammer. Motion carried.

There was no motion to approve committee attendance at Committee meetings or functions.

A motion to approve department's monthly bills was made by Supervisor Bosman and seconded by Mike Rammer. Motion carried with Supervisor Ogea voting nay.
