The Sheboygan County Transportation Committee convened at 9:30 a.m. Chairman Winkel presiding. Chairman Winkel noted that the meeting was posted on September 8, 2010 at 2:30 p.m. in the lobby of the Administration Building in compliance with the open meeting law.

It was moved by Supervisor Conrardy and seconded by Supervisor Wagner to approve the minutes of the September 7, 2010 Transportation Committee meeting. Motion carried.

Dave Rudd of the Aviation Heritage Center requested support from the Transportation Committee with regard the Aviation Heritage Center obtaining a Class B license. Supervisor Conrardy made a motion and Supervisor Wagner seconded the motion to authorize Airport Manager Mayer send a letter to the Town of Sheboygan in support of the Aviation Heritage Center's pursuit of a Class B license. Roll call vote with Supervisors Winkel, Holub, Bemis, Wegner and Conrardy voting AYE. Motion carried.

Commissioner Schnell discussed the speed zone on CTH "LLL" south of CTH "RR" and the possibility of extending the current 35 mph speed limit 346' south of the current 35 mph zone. Supervisor Holub made a motion and Supervisor Conrardy seconded the motion to approve the reduction of speed as outlined by Commissioner Schnell. Roll call vote with Supervisors Winkel, Holub, Wegner and Conrardy voting AYE and Supervisor Bemis voting "NAY". Motion carried.

Commissioner Schnell discussed a reduction of speed on CTH "PP" between STH 57 and STH 67 from 55 mph to 45 mph. Supervisor Conrardy made a motion and Supervisor Wegner seconded the motion to approve the reduction of speed as outlined by Commissioner Schnell. Roll call vote with Supervisors Winkel, Holub, Wegner and Conrardy voting AYE and Supervisor Bemis voting "NAY". Motion carried.

Commissioner Schnell discussed correspondence he received from Michael and Pamela Deppiesse regarding CTH "LL" and CTH "LLL" intersection. Commissioner Schnell advised we are going to clean up the right of way and develop a plan to redesign the current cross section in the future.

Supervisor Holub made a motion and Supervisor Bemis seconded the motion to forward Sheboygan County Resolution No. _____ (2010/11) Re: Authorizing County Aid for Bridge/Culvert Construction in Towns of Herman, Holland, and Lima to the County Board. Motion carried.
