Chairman Koch called the meeting to order. Peggy Osthelder verified that the meeting notice was posted on April 22, 2021 at 1:00 P.M. in compliance with the open meeting law.

Supervisor Ziegelbauer made a motion to approve the minutes of the March 29, 2021 Executive Committee meeting. Motion seconded by Supervisor Abler. Motion carried unanimously.

Consideration of Resolution No. 01 - Disallowance of Roe Claim Against Sheboygan County. Corporation Counsel Crystal Fieber gave an overview of the resolution and answered questions. Supervisor Goehring made a motion to approve the resolution and authorize Peggy Osthelder to sign the document on behalf of the Committee. Motion seconded by Supervisor Ziegelbauer. Motion carried unanimously.

Consideration of Resolution No. 03 - Adoption of the Sheboygan County Comprehensive Outdoor Recreation & Open Space Plan 2021. Planning & Conservation Director Aaron Brault gave and overview of the plan and answered questions. Supervisor Goehring made a motion to approve the resolution and authorize Peggy Osthelder to sign the document on behalf of the Committee. Motion seconded by Supervisor Ziegelbauer. Motion carried unanimously.

Consideration of Resolution No. 05 - Approving First Amendment to Sheboygan County Airport Ground Lease with Sheboygan County Aviation Corp. Airport Superintendent Matt Grenoble gave an overview and answered questions. Supervisor Procek made a motion to approve the resolution and authorize Peggy Osthelder to sign the document on behalf of the Committee. Motion seconded by Supervisor Ziegelbauer. Motion carried unanimously.

The Committee discussed the County Board Annual Leadership Forum Agenda. County Administrator Adam Payne provided an overview of the draft agenda, and invited the Executive Committee to make suggestions. The Committee discussed the agenda and provided feedback.

Discussion regarding in-person County Board meetings. Chairman Vern Koch shared that vaccines are now readily available, and thought that most board members have been vaccinated. In addition, the County Board Chambers has plexi-glass dividers, and there is adequate space for supervisors to social distance. Chairman Koch requested input from the Executive Committee on re-establishing in-person County Board meetings beginning in May. The Committee discussed and provided favorable input for holding the May 18 County Board meeting in-person, with the virtual zoom connection option for those supervisors, staff and

members of the public who are more comfortable participating remotely.

County Administrator Adam Payne reported on a number of activities including: the recent tree sale held by the Planning and Conservation Department; the Amsterdam Dunes Mitigation Bank was approved and next steps; a roundtable discussion that he and Chairman Koch had with Governor Evers and other officials regarding the need for more affordable housing; the 2022 budget development process and budget assumptions memo; ideas to enhance employee appreciation; an update on the Bookworm Gardens lease expansion request; exploring a potential partnership with Discover Wisconsin to showcase Sheboygan County; the upcoming Heads of Local Government meeting; the status of the federal stimulus funds; and Ryder Cup plans and preparations.

Vouchers were reviewed. Supervisor Goehring made a motion to approve the vouchers and authorize Peggy Osthelder to sign them. Motion seconded by Supervisor Ziegelbauer. Motion carried unanimously.

The next Executive Committee meeting is scheduled for Monday, May 24 at 3:30 pm.
