JOURNAL OF THE MEETING OF THE SHEBOYGAN COUNTY BOARD OF SUPERVISORS

January 19, 2010

Pursuant to Section 59.11 of the Wisconsin Statutes, the January 19, 2010 session of the Sheboygan County Board was called to order by Chairperson Michael J. Vandersteen at 6:00 p.m. Chairperson Vandersteen noted that the notice of meeting was posted on January 13, 2010 at 1:45 p.m. in compliance with the open meeting law. The meeting opened with the Pledge of Allegiance by all present.

The roll call was taken and recorded with 31 Supervisors present; Absent: 3, Supervisors Anic, Riemer, and Ziegelbauer.

Supervisor Winkel made a motion for approval of the December 15, 2009 Journal, which was distributed to all supervisors prior to the meeting. The motion was seconded by Supervisor Glavan and carried on unanimous roll call vote of the board.

APPOINTMENT

The Chairperson announced that the next order of business was the consideration of the re-appointment by the County Administrator of **Linda Bosman** to the Eastern Shores Library System Board.

Supervisor Marthenze made a motion to concur with the re-appointment. The motion was seconded by Supervisor Goehring and carried on unanimous voice vote of the board.

LETTERS AND COMMUNICATIONS

The Clerk presented a report on Public Officials Bonds for 2010. By Chairperson referred to the Executive Committee.

The Clerk presented a resolution from the Outagamie County Board of Supervisors requesting the legislature to allow counties to borrow funds for the purpose of purchasing delinquent taxes. By Chairperson referred to the Finance Committee.

The Clerk presented a resolution from the Outagamie County Board of Supervisors in opposition to Assembly Bill 349 regarding public access to property tax information searches by name. By Chairperson referred to the Finance Committee.

The Clerk presented a resolution from the Outagamie County Board of Supervisors in opposition to proposed state legislation requiring child custody study reports to be submitted to both the Court and parties at least 10 days prior to being introduced into evidence. The Clerk presented a resolution from the Outagamie County Board of Supervisors in support of proposed state legislation allowing governmental units to release audio public records of 911 calls as transcripts when requested and to release them as audio recordings at the discretion of the governmental unit in possession of the recording. The Clerk presented a resolution from the Brown County Board of Supervisors in support of federal funding for welfare fraud investigation. By Chairperson referred to the Law Committee.

The Clerk presented a resolution from the Langlade County Board of Supervisors in support of maintaining the current law regarding jurisdictional amounts and court fees in small claims actions. By Chairperson received for information.

The Clerk presented a resolution from the Fond du Lac County Board of Supervisors encouraging the Governor and Legislature to acknowledge and act upon the final report of the Northeast Wisconsin Karst Task Force (water quality). By Chairperson referred to the Planning, Resources, Agriculture and Extension Committee.

The Clerk presented a resolution from the Racine County Board of Supervisors in support of Assembly Bill 392 to end predatory lending in Wisconsin. By Chairperson referred to the Executive Committee.

The Clerk presented a resolution from the Dodge County Board of Supervisors in opposition to Assembly Bill 145 regarding legislative review of municipal ward plans. By Chairperson referred to the Executive Committee.

Supervisor Goehring made a motion to adopt the resolution. The motion was seconded by Supervisor Te Stroete and carried on unanimous roll call vote of the board.

The Clerk read the report of the Health and Human Services and Health Care Centers Committees regarding **Resolution No. 37 (2009-2010) Combining Health and Human Services and Health Care Centers Committees** recommending filing with the clerk. Concurring with the report from the Health & Human Services Committee was Supervisor Otten; opposed Supervisors Van Der Male, Feider, and Koch. Concurring with the report from the Health Care Centers Committee were Supervisors Conrardy, Otten, Medina, Hoffmann, and Ziegelbauer. Supervisor Conrardy made a motion to grant additional time until the February 16, 2010 County Board meeting. Supervisor Van Der Male seconded the motion which carried on roll call vote of the board of Ayes: 32; Noes: 1, Supervisor Otten; Absent: Supervisor Anic.
