DISCUSSION/POTENTIAL ACTION REVIEW PRELIMINARY SHEBOYGAN RIVER ACC HABITAT PROJECT

DISCUSSION/POTENTIAL ACTION CONCEALED CARRY ON COUNTY PROPERTY

Carl Buesing, Corporation Counsel explained history behind request to draft ordinance prohibiting carrying concealed weapons in County-owned buildings as specific buildings are not clearly defined in the Concealed Carry Law enacted November 1, 2011. Following discussion, moved by Glavan/seconded by Raml to approve Sheboygan County Ordinance No. (2011/12) Re: Regulating Firearms in County Buildings as drafted by Corporation Counsel and forward to County Board for adoption; seconded by Raml. Motion carried.

DISCUSSION/POTENTIAL ACTION SHEBOYGAN COUNTY MUSEUM LEASE UPDATE -

Buesing noted the Museum Board expressed some concerns regarding the proposed lease. He will be meeting with Attorney Bill Holbrook, Bob Harker and Mary Novak on Wednesday – February 8, 2012 and will report back at the next Property Committee meeting.

DISCUSSOIN/POTENTIAL ACTION UNIVERSITY OF WISCONSIN SHEBOYGAN ENERGY AUDITS

The State of Wisconsin set aside \$100 million to improve energy efficiency of State properties where the State pays utilities expenses; a portion could apply to the University of Wisconsin Sheboygan. Once three audits are completes, will bring proposal back to Committee for final decision on what improvements to make.
